

Privacy Statement and Cookie Files

No.1 DEVELOPMENT s.r.o. IČO: 089171116, with its registered office at Na strži 1702/65, 140 00, Prague 4 (hereinafter referred to as '**No.1**'), operates the website www.adriandravta.cz (hereinafter referred to as the '**website**'). Your personal data is processed by No.1 as the controller, meaning that it determines how personal data will be processed, for what purpose, for how long, and selects any other processors who will be involved in the processing. No.1 respects the right to privacy and personal data protection of all individuals who visit the website or contact No.1 through it, by phone, or by email (hereinafter also referred to as '**visitor**', '**user**,' or '**you**'). The processing of your personal data is carried out in accordance with applicable laws, in particular, Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016.

o on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC.

The purpose of this Privacy Statement and Cookie Files (hereinafter '**Statement**') is to inform you about how No.1 will process your personal data, in particular the categories, scope, and purpose of processing, and the individuals to whom No.1 may disclose your personal data. You will also find information about your rights related to the processing of personal data.

o By providing your personal data, you accept this Statement and acknowledge that No.1 may process your personal data in the manner and for the purposes described below. If you do not agree with this Statement, please do not provide your personal data.

1 | What are personal data

Personal data includes all information about an identified or identifiable natural person, such as name, address, email address, telephone number, or IP address.

2 | What personal data about you does No.1 collect?

No.1 collects only the personal data that you voluntarily provide or that No.1 obtains through the website or in communication with you.

The personal data that No.1, as the controller, collects and processes about you may include:

- a) Your identification and address information (e.g., title, name, surname, address);
- b) Your contact details (e.g., contact address, email, and phone);
- c) Electronic data (e.g., IP address, cookie files, browser type);
- d) Other data that you provide yourself or that No.1 collects in connection with the provision of agreed services and products

3 | Why does No.1 process personal data?

No.1 processes personal data for the purpose of providing services and fulfilling contracts, as well as for marketing purposes. You are not legally obligated to provide your personal data; providing personal data is entirely voluntary. However, without providing personal data, No.1 may not be able to provide the requested services or respond to your requests and inquiries (either at all or in the desired quality).

4 | Cookie Usage Policy

To enhance service delivery, the website uses cookie files. Cookie files are small files stored in your browser or on your computer's hard drive. Cookies help your computer remember visited pages and your preferences on visited pages (e.g., preferred language). Data obtained through them is used by No.1, for example, to provide services, personalize advertisements, and analyze website traffic.

If you do not agree with the use of cookie files on the website, you can disable cookie file storage using your browser settings.

5 | Who are the recipients of your personal data?

If the services or products you have requested are provided by a person other than No.1, No.1 may disclose your personal data to such service or product provider. The purpose of such transfer of your personal data is to provide the requested service or product. The service or product provider will process your personal data independently of No.1 as a separate data controller.

In the necessary extent, your personal data may be transferred to a processor with whom No.1 has concluded a personal data processing agreement. No.1, as the data controller, has access to your personal data, and, if necessary, other individuals with whom No.1 cooperates in its activities may have access to it. These colleagues have access only to the data they need to provide the service and only for the necessary period.

Furthermore, No.1 may provide your personal data to a requesting authority of public power (e.g., a court or the police in the Czech Republic) in the scope and under the conditions set by applicable laws. These recipients will process your personal data independently as separate data controllers.

6 | Are your personal data transferred outside the EU or EEA?

In general, personal data obtained by No.1 through the website are not transferred outside the European Economic Area (EEA). However, if any of the recipients of your personal data processes personal data in a country outside the EEA, No.1 may transfer your personal data to such a third country. In such a case, No.1 will ensure that your personal data are transferred with appropriate safeguards (e.g., by entering into standard contractual clauses with the recipient of the personal data).

7 | Collecting and Processing Children's Personal Data

If you are under 15 years of age and wish to give your consent for the processing of your personal data through the website (e.g., by subscribing to our newsletter), please ask your parents, guardians, or other legal representatives for approval before providing any personal data. Without such approval, you are not authorized to provide your personal data.

8 | Data Security and Data Retention Period

To protect your data from unauthorized access and against unlawful processing, accidental loss, destruction, and damage, No.1 uses strict physical, electronic, and administrative security measures.

No.1 will retain your personal data only for as long as is necessary for the purpose of processing and then for the period required by law. Personal data processed based on your consent will be processed by No.1 only until such consent is revoked.

9 | What rights do you have in the field of personal data protection?

In connection with the processing of your personal data, you have a number of rights. However, certain exceptions apply to the exercise of these rights, and therefore, they may not be applicable in all situations. If you exercise your rights, and your request is considered legitimate, No.1 will take the necessary action without undue delay, no later than one month from the receipt of your request (in reasonable cases, this period may be extended by an additional two months). **An overview of visitors' rights:**

- a) **Right of Access:** You have the right to access the personal data that No.1 processes about you.
- b) **Right to Rectification:** You can request No.1 to correct inaccurate personal data.

- c) **Right to Erasure** You can request No.1 to erase the processed personal data under the conditions specified in Article 17 of the GDPR.

- d) **Right to Withdraw Consent** If the processing of personal data is based on your consent, you can withdraw such consent at any time and thereby prevent further processing for the purpose stated in that consent. However, the lawfulness of the processing before its withdrawal is not affected.

- e) **Right to Object** If No.1 processes your personal data based on legitimate interests, you have the right to object to such processing.

- f) **Right to Restriction of Processing** In certain cases, you may request that No.1 restrict the processing being performed (e.g., until your objections are resolved)

- g) Right to Data Portability** You can request No.1 to provide you or a third party with the personal data that we process about you in electronic form based on a contract or your consent.
- h) Right to Lodge a Complaint** If you believe that your personal data is being processed in violation of the law, please contact No.1 and we will promptly address the issue. However, you also have the right to file a complaint directly with the Office for Personal Data Protection (www.uoou.cz).
